Principal and Member Secretary Dr. K. Kanibasappa extended a warm welcome to all the members of the Governing Council on behalf of the Management, HODs & Faculty, Students and sought permission of the Chair to proceed with the Agenda.

Subject No. 1:- Confirmation of draft of the proceedings of the previous meeting held on 08-01-2016.

The draft minutes of the proceedings of the previous meeting held on 08.01.2016 were circulated for suggesting corrections if any. Few corrections were suggested. They were incorporated. It was resolved to record accordingly.

Subject No 2:- Review of the action initiated on the policy decisions enumerated in the earlier meetings.

Follow up action deliberated on the important policy decisions emerged in the last two meetings were taken up for review. Some more decisions are yet to be implemented. The Principal shall evince personal interest in giving effect to such policy decisions.

Subject No.3:- Acquisition of Land to the extent of 2858.05 Sq.mtrs. (28.247 guntas) occupied by TOCE by KIADB under Metro Rail Project.

Final notification has been issued by

KIADB u/s 28(4) KIADB Act 1966 acquiring vacant land, compound, gate and ATM Room and also Generator Room under Metro Rail project bearing Survey No. 4/9 & 57, measuring in all 2858.05 Sq. mtrs. The Oxford College Metro Rail Station will be constructed in terms of the project report. The Compensation payable is still under Consideration of KIADB in Consultation with BMRCL whether the college suffers any deficit in holding the land in fulfillment of norms prescribed in the AICTE Regulation. The norms have recently been revised by amending the AICTE Regulations prescribing the total extent of land in Metropolitan area. As per the Revised norms 2.5 acre for Engineering College, 1 acre for Architecture Course, 0.5 acre for MCA Course and 0.75 acre for MBA Course have been stipulated. However, the COA Regulation prescribe 8000 Sq. mtrs of land. Even after acquisition there is no scope for deficiency. Only after dismantling the Compound and gate fresh Construction Civil work will have to be taken up. All the members were unanimous that adequate compensation should be claimed invoking the Right to Fair Compensation and Transparency in Land acquisition Rehabilitation and Resettlement Act 2013 which came into force from 01-04-2015.

Subject No. 4 :- Inaugural function for the academic year 2016-17.

The process of admission to First year B.E B.Arch both under Govt. quota and Management quota is in progress. The first semester classes shall commence from 01-08-2016.

Inauguration function may be held on the same day. An eminent personality in the field of Technical Education may be invited as chief Guest to grace the occasion in the meantime appointments to the existing vacancies of the faculty shall be made.

Subject No. 5 :- Conduct of Conference / Seminars / workshop / Symposiums :

As a part of enrichment program and add on D programs, Certain Conferences, Seminars, workshops and Symposiums were held during the last six months. They include certain programs sponsored by Software Companies and other companies and also some individuals. In pursuit of post accreditation activities of NAAC/NBA such programs held are quite inadequate. Value added programs outreach programs and add on programs should be also held under the guise of behind curriculum activities. After a good deal of deliberation, it transpired that many more such programs should be held and FODs shall contact the companies in and around and IT hub to sponsor not only such programs but also to depute eminent personalities in such areas or Specialization.

Subject No. 6 :- Conduct of FDP / FP / Refresher Courses etc.

In order to comply with the norms and requirements of the AICTE, the following programs should be held in a phased manner in each

academic year to reorient the faculty and for their updating of professional skills and knowledge and the latest trends in their area of specialization.

- 1) Foundation Course
- 2) Refresher programs
- 3) Reorientation programs
- 4) FDP/FIP.

A calendar of programs should be drawn up for conduct of each of the above programs staggeringly over a period of the entire academic year. Resource persons from various fields should be invited to deliver key note address. Conduct of each program may be taken up for further review in the next meeting.

Subject No. 7 :- Review of activities carried out by many Committees in post accreditation period.

Eleven no. of committees have been constituted for carrying out the post accreditation activities of NAAC/NBA. The NAAC Coordinator and the Principal should ensure that each committee meets as frequently as possible at least once in 15 days to analyse its assignments and accomplishments. Proper minute book duly recorded of the proceedings shall be maintained for the purpose of proper documentation.

Subject No. 8 :- Functioning of Anti-Ragging Committee, Students Grievances Redressal Committee

Invoking the provisions contained in

the AICTE Regulations Collaborated with the directions of the VTU the Anti-Ragging Committee to spread the message of Ragging in the College premises and also in the Hostels has been constituted. Undertakings have also been obtained from the Students at the time of admission that they would not indulge in any act of Ragging. The Committee took note of having displayed the Boards Cautioning the Students of the result of Ragging and also the Contact Telephone numbers of the Committee members. However, it is felt that the Principal, Vice-Principal and HODs shall conduct awareness programs in the College and hostels for the knowledge of the senior students about the civil impact of having involved such acts which are punishable offence and non-punishable. Student's Grievances Redressal committee has also been constituted in terms of AICTE Regulations. A mechanism has also been developed for redressal of any grievances or hardships met by them. The mechanism should be further strengthened and developed to ensure that the Students should be free to approach the HODs and Principal primarily and ultimately the Committee. The members felt that the Committee shall meet immediately after receipt of any complaint and put the mechanism in motion for an effective solution.

The meeting was concluded by vote of thanks by the Principal.

The major & minor Research projects may be taken up by students & faculty for publication of Research papers. The HODs shall make it a point to contact the various funding agencies for assignment of Research Project as part of syllabus and to boost Research.

Subject No.9: Conduction of National Conference in the month of May 2017

It is proposed to conduct National Conference in the month of May inviting technical papers from outside colleges and also to encourage our Ph.D Scholars & M.Tech Students to present papers in the Conference.

1. Principal invited HODs to take the initiative of conducting National Conference. HODs told let College Research Coordinators take the initiative and we will support them in all respect. Dr. B.K. Marjumath, Professor, Dept. of Biotechnology and Dr. Preeta Sharan, Professor Dept. of ECE were nominated as Chief Co-ordinators of National Conference and Research Co-ordinators across the departments as members. Dr Marjumath suggested to nominate senior faculty for Research Co-ordinators. Chief Co-ordinators were advised to invite resource person with respected background, prepare budget and fix registration fee which shall include file and lunch. Ph.D Scholars and M.Tech Students shall present their papers and U.G Students shall present in groups. Registration fee shall be fixed for our students also. 09. Accreditation of Departments of ME, BT, CV, ECE by NBA

Online applications were submitted in January 2018 to NBA for accreditation of the departments of ME, BT, CV, ECE. All the supplementary documents sought for were submitted. The Expert Committee visited College on 03.05.2019. The assessment of each department was carried out by the Committee including Chairman who vetted all the documents and records. The presentation was made much effectively by the HODs and faculty. Interaction was also very much useful whatever the queries raised by them were clarified with supportive documents. The certificates of accreditation valid for 4 years are still awaited. The Governing council satisfied upon review of the scenario suggested that during the next visit of the NBA on 30th, 31st August 2019 and 1st Sept 2019, the presentation should be very much effective to haul 'A' grade.

10. Procurement of Equipments, Applicances, Chemicals, Glasswares And Consumables.

In order to rationalize the system of purchase of equipments, consumables, glasswares and other procurement of services through service providers a Purchase Committee has been constituted in the notification dated 20.09.2019. Under the Chairmanship of the Principal involving HODs concerned, Managers from Purchase Section & Accounts / Audit sections. Based on the recommendations of the Purchase Committee approval has been accorded for such procurements after following the Procedure Prescribed in the Administrative and Service manual and also a good deal of negotiations with the suppliers.

11. Analysis of the Results of BE/BARCH Courses of ODD Semester.

Analysis of the results of 1st, 3rd, 5th & 7th Semesters BE, 1st, 3rd and 5th Sem MCA and 1st and 3rd Semester of MBA course reveals that the percentage of results is an average of 70%. But in some branches like Automobile, ME, CSM and Civil Percentage is below 50%, hence, the HODs and the faculty should make efforts by conducting special classes for improvement of the results in the next semester examinations. It was pointed out that the CSM course has been wound up with the approve of the AICTE and withdrawal of affiliation of the VTU. Since, the students were not attracted by the said course resulting in dip in admissions.

The Governing Council concluded that there is much scope for further improvement of the results and sincere endeavor should be made by the teachers effectiveness overseen by the HOD, Principal & Director.



Proceeding of the Meeting of the Governing Council held on 02-01-2020

Subject 1 :- Confirmation of minutes of previous meeting held on 06-07-2019

The draft minutes of the earlier meeting held on 06-07-2019 were read over. Slighting modifications and correcting it if any. Few amendments were suggested. It was resolved to record the minutes of the meeting duly incorporating the corrections.

Subject 02 : Review of the follow-up action initiated on the Resolutions Emerged in the previous meetings held in the recent past.

Implementation of the important Resolutions emanated in the earlier meetings have been taken up for review. Almost all the significant decisions have been given effect to.

Subject 03 : Recognition of The Oxford College of Engineering by UGC Under Section 12 B of UGC Act, 1956.

Formal application was submitted to UGC for grant of recognition of TOCE under Section 12 B of UGC Act, 1956 in the year 2016. In the UGC letter dated 27-10-2016 it was informed that VTU was not recognized by UGC under Section 12 B as such Affiliated Colleges are not eligible for such recognition until VTU enjoys recognition by UGC. During the academic year 2018-19 VTU had secured UGC recognition for receiving the grants. Immediately UGC was requested to consider grant of recognition

to TOCE under Section 12 B. Acting on it UGC sought a Certificate from Registrar of VTU to the effect that the College has fulfilled all the conditions prescribed for permanent affiliation. In the mean time the period of permanent affiliation had expired for the academic year 2017 - 2018. Hence such a certificate was not issued.

After a brief discussion it was suggested that an application may be submitted for grant of permanent affiliation. Only after the permanent affiliation is granted by the Government the matter may be taken up with the UGC for recognition under Section 12 B.

Subject 04 : Accreditation of certain Departments by NBA
 Separate applications were submitted for Accreditation of the following Departments by NBA from the academic year 2019-20.

(1) ECE, (2) BT

(3) Civil Engineering

(5) Automobile Engineering

(4) Mechanical Engineering

(6) Mechatronics Engineering

An expert team visited the college and conducted on site evaluation of the programmes from 03-05-2020 to 05-05-2020 and from 30-08-2019 to 01-09-2019. The expert team had recommended grant of Accreditation to (1) ECE Department, (2) Biotechnology Engineering Department and (3) Mechatronics Engineering Department Valid for the academic years 2021-22 up to 30-06-2022.

After an extensive discussion it was resolved to apply for Accreditation of other Departments fulfilling the mandatory norms in the academic year 2020-21.

Subject 05: Placement and Training Activities.

Routine training on Soft Skill Development, Personality Development, Latest Vocabulary in Communication, English and Motivation Programmes have been conducted having a tie-up with the Companies involved in such Training Programmes, like


Subject 12 : Increase of intake of BE in CSE from 120 to 180
